Land Acknowledgement

We acknowledge that the land on which our projects are located is the ancestral and unceded territory of the Tahltan Nation, and the territory of the Tsetsaut Skii km Lax Ha'. We are honoured to be guests in this territory where we live, work and learn. We also acknowledge that the project proposes a concentrate transportation route which would pass through the Nass and the Nass Wildlife Areas (as defined in the Nisga'a Final Agreement) of the Nisga'a Nation and the territory of the Gitanyow Nation.

¹As in the Hybrid Application Information Requirements, for the purposes of this document, "territory" is defined as the established or asserted traditional territories of Indigenous Nations, except in relation to the Nisga'a Nation, which refers to Nisga'a Lands, the Nass Area, and the Nass Wildlife Area, as applicable.



Reconciliation in Action: We’re on the Right Path

Throughout my career in the mining industry, I’ve envisioned a model where First Nations are genuine partners in resource development and not just stakeholders or communities of interest. I’ve long supported and championed the drive toward First Nations decision-making authority over activities on their lands, including the right to manage and benefit from them.

Seeing that vision come to fruition at Skeena is a deeply meaningful milestone for me, both personally and professionally. As a Tahltan myself, I have immense pride in Skeena’s partnership with the Tahltan Nation and securing First Nations government consent for the Eskay Creek project, a next-generation mine located in Tahltan Territory. This is truly reconciliation in action.

Implementing the Impact Benefit Agreement (IBA) will be central to our work in 2026. We have joint environmental oversight and project advisory committees to help us ensure that Tahltan knowledge and values are embedded in our operations. We’re also building out the on-site environment team at Eskay Creek, which will include Tahltan Environmental Stewards who serve as the Tahltan eyes and ears on the ground. They will make sure environmental and cultural priorities are maintained and be an important point of connection to their people back home.

I’m eager to see Eskay Creek come to life and our relationship with the Tahltan Nation continue to strengthen. Our approach to the mine’s construction and subsequent production will reflect the same partnership mindset that guided our research and planning. Because at our core, collaboration comes first, and that will never change.

Ultimately, my goal is to set a high standard for how we develop and operate Eskay Creek, so the Tahltan Nation can say, “Skeena is doing an amazing job.” We are on that path.

We did it!

Eskay Creek is Fully Permitted and Under Construction

Eskay Creek has officially completed the Environmental Assessment Certificate (EAC) process in B.C., with positive final decisions from the Tahltan Central Government, the Government of B.C. and Federal Government. This major milestone for the project is a defining moment in Skeena's history and is the culmination of over four years of extremely hard work by members of our team in advancing a rigorous environmental assessment.



Historic first in Canada

The multi-year process involved significant collaboration with the Tahltan Central Government, other Indigenous governments and organizations, and local, provincial and federal governments. We held more than 100 engagement sessions on the project as well as hundreds of meetings to make sure it reflects the interests of the people and communities it will affect.

Skeena's Karen Leven, VP of Environment and Regulatory Affairs, underscores the EAC's broader significance for Canada and Indigenous communities: "The EAC is groundbreaking because the Tahltan Nation's consent to the Eskay Creek project is embedded within the EAC, marking a historic first in Canada through a landmark Section 7 agreement signed in 2022 between the Government of British Columbia and the Tahltan Central Government."

Major mine permits approved

Alongside the EA process last year, we also submitted our major mine permits. Adds Karen: "These activities happened at the same time and involved managing a very rigorous existing regulatory regime, on top of integrating a completely new Section 7 process, which is something that has never been done before."

Skeena received the final permits in early 2026, clearing the last regulatory approvals required to advance Eskay Creek into commercial development.

Responsible resource development

As part of the official announcement, the Honourable Jagrup Brar, Minister of Mining and Critical Minerals, stated: "I congratulate Skeena on reaching this important milestone with the receipt of the final permit to commence full-scale construction at Eskay Creek. This achievement represents a significant step forward in responsible resource development that supports jobs, strengthens local economies, and aligns with our shared commitment to environmental stewardship. We look forward to the positive contributions this project will bring to British Columbia's mining sector and to the communities it supports."

Project Update: Reaching the Midway Mark

Heading into spring, we're pleased to report that the Eskay Creek project is about halfway complete.

Among the major highlights, we have made strong progress on the process plant, water treatment and management systems, camp construction and electrical infrastructure.

Our strategy of early preparation and initiating development work before receiving final permits allowed us to get a jump on initial activities. By acting early, we reduced project timeline risk and minimized inflationary impacts across key scopes by securing procurement contracts earlier. Initial production remains on schedule, targeted for the second quarter of 2027 and commercial production expected in the third quarter.

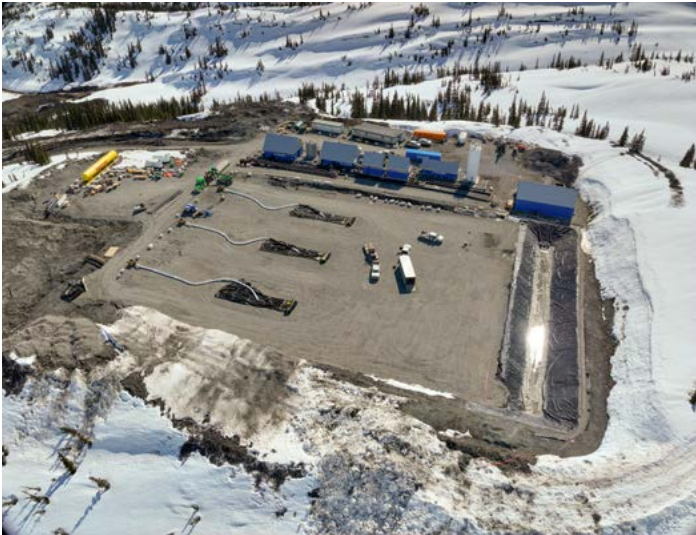

During AME Roundup, Precious and Stephany took part in the Skeena Student Networking Event, the Women at Roundup event and Tahltan Night, and attended the historic signing of Skeena's Environmental Assessment Certificate alongside members of the Tahltan Nation.

They also gained hands-on experience working at our tradeshow booth, engaging with industry partners and enriched their understanding of mining's role in Indigenous communities and the vast range of employment opportunities it offers.

Beyond the formal programming, the experience was deeply meaningful on a personal level. Both met relatives for the first time and spoke with Tahltan Elders, strengthening their cultural connections and sense of belonging. Precious and Stephany also toured Skeena's head office in Vancouver and met with members of our senior leadership and talent acquisition and human resources teams, gaining further insight into potential career pathways within the Company.

Overall, this initiative was a tremendous success for them, and we look forward to watching their careers flourish at Skeena.

With construction well underway and initial production on schedule for 2027, Eskay Creek is projected to employ 1500 people during Construction and 950 during Operations. 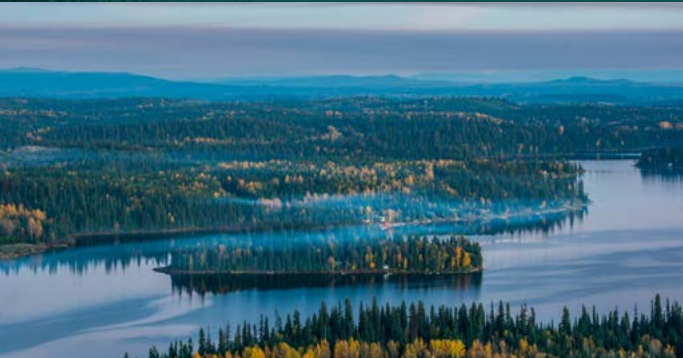

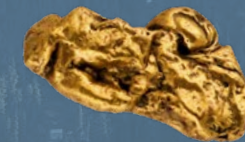

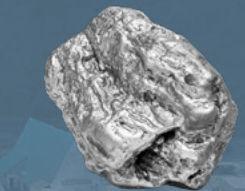
Fast Facts

What will Eskay Creek look like in Operations?



High Grade

Eskay Creek will be one of the highest-grade open-pit gold mines in the world, with an average grade of 5.5 gpt gold equivalent in its first five years of production – more than triple the average grade for open-pits worldwide.



Canada's Largest Silver Mine

Eskay Creek will produce an average of 9.5 Moz of silver per year during years 1 – 5, making it the largest silver mine in Canada.



Low-Cost, Clean Hydro Power

Eskay Creek will be powered by clean and low-cost energy from a nearby hydroelectric facility, with rates positioned well below global mining industry energy cost standards.



Direct Jobs: 1500 During Construction, 950 During Operations

Eskay Creek will be a cornerstone of economic growth for the Province of British Columbia, supporting workers, businesses and long-term regional growth.
